Privacy Notice

January 2023

What we need

Strathclyde Park Rowing Club is a rowing club based at Strathclyde Country Park, Motherwell, and provides the opportunity to row within the local community. The club is a Scottish Charitable Incorporated Organisation and is affiliated to Scottish Rowing, the sport's governing body in Scotland.

Strathclyde Park Rowing Club will be a "controller" of the personal information that you provide to us through this website, via email or on paper, unless otherwise stated.

Members' personal data:

When you register as a member of Strathclyde Park Rowing Club or renew your membership (including if you are registering or renewing on behalf of a child under the age of 18), we will ask you for the following personal information:

- contact details – name, address, email address, contact telephone numbers, date of birth, emergency contact details and, for juniors, parent or guardian contact details;
- membership criteria / category – for example, athlete, volunteer;
- participation details – for example, athlete, volunteer;
- details of your General Practitioner and any relevant medical information;

Volunteers' personal data:

When you volunteer with Strathclyde Park Rowing Club, we will ask you for the following personal information:

- contact details – name, address, email address, contact telephone numbers, date of birth, emergency contact details and, for juniors, parent or guardian contact details;
- participation details – for example, parent, committee;
- details of your General Practitioner and any relevant medical information;
- PVG membership and relevant qualifications as appropriate.

Why we need your personal information – contractual purposes

Members' personal data:

We need to collect our members' personal information so that we can manage your membership. We will use our members' personal information to:

- provide you with core member services, including entry to regattas and other events, arranging training sessions, etc.
- send you membership communications by post or email in relation to essential membership services, including but not limited to, annual or extraordinary general meeting notices, membership renewals, membership fees' information, etc.

If you do not provide us with all of the personal information that we need to collect then this may affect our ability to offer the above membership services and benefits.

Why we need your personal information – legitimate purposes

Members' personal data:

We also process our members' personal information in pursuit of our legitimate interests to:

- promote and encourage participation in rowing by sending members' communications and booking information for upcoming competitions and social events;
- provide competition in rowing by accepting and managing entries for our competitions and checking your personal information to ensure you are entered into the correct category;
- monitor and develop participation in rowing by monitoring members' engagement and participation;
- invite our members as award winners or guests to our annual awards dinner, which includes asking our members to nominate individuals for awards and shortlisting such individuals to select the winners, who we will then contact by email;
- develop and maintain our members' qualifications, including sending email communications to members to inform you of upcoming courses, renewal requirements and verify that you have completed any mandatory training and PVG / child protection requirements;
- respond to and communicate with members regarding your questions, comments, support needs or complaints, concerns or allegations in relation to rowing.
- assist you with applications to attend competitions, events, training courses, etc

We seek medical data for rowing members as this may assist in the response to a medical emergency.

Our competitions and events may be filmed or photographed and your personal information may also be used in images captured from our competitions, events and training sessions, which we use for promotional, education and development purposes. We will follow Scottish Rowing's "[Recording Images of Children](#)" policy, and we will seek the parent's permission before filming or photographing junior members.

Where we process your personal information in pursuit of our legitimate interests, you have the right to object to us using your personal information for the above purposes. If you wish to object to any of the above processing, please contact us at secretary@strathclydeparkrc.co.uk. If we agree and comply with your objection, this may affect our ability to undertake the tasks above for the benefit of you as a member.

Volunteers' personal data:

We keep data on coaches' experience and courses attended to be able to demonstrate they are adequately qualified to perform the services they provide.

Why we need your personal information – legal obligations

Members' personal data:

We are under a legal obligation to process certain personal information relating to our members and volunteers for the purposes of complying with our obligations under Scottish charity laws, which includes our members' name, address, the date they were admitted to membership and the date on which they ceased to be our member, as well as attendance at annual and extraordinary general meetings;

Volunteers' personal data:

We will need to collect personal information relating to criminal convictions or alleged commission of criminal offences where you are required to complete a PVG check under the Protection of Vulnerable Groups (Scotland) Act 2007. This information will include your PVG certificate number, PVG membership number, date of issue and any relevant information in relation to your membership of the PVG Scheme.

If your PVG certificate is not clear, we will have a legitimate interest to collect references and any other applicable information to allow us to consider whether or not you can volunteer in a regulated role with children and/or vulnerable adults.

Where we process your personal information in pursuit of our legitimate interests, you have the right to object to us using your personal information for the above purposes. If you wish to object to any of the above processing, please contact us on secretary@strathclydeparkrc.co.uk. If we comply with your objection, this may affect our ability to undertake the tasks above for the benefit of you as a volunteer.

Other uses of your personal information

We may ask you if we can process your personal information for additional purposes. Where we do so, we will provide you with an additional privacy notice with information on how we will use your information for these additional purposes.

Who we share your personal information with

If your personal information is included in any images or videos taken by us at our competitions and events, we may share this for promotional and/or journalistic purposes.

We may be required to share personal information with statutory or regulatory authorities and organisations to comply with statutory obligations. Such organisations include the Health & Safety Executive, Disclosure Scotland, and Police Scotland for the purposes of safeguarding children and other legal requirements.

We may also share personal information with our professional and legal advisors for the purposes of taking advice.

In the event that we do share personal information with external third parties, we will only share such personal information strictly required for the specific purposes and take reasonable steps to ensure that recipients shall only process the disclosed personal information in accordance with those purposes.

As a member club of Scottish Rowing we are required to ensure that all of our rowing members are members of Scottish Rowing as a condition of our membership. You will be required to register on the online membership system and by doing so, you will be agreeing to the Membership System Privacy Policy as found on <https://scottishrowing.azolve.com/>.

We will share details of our members with Scottish Rowing as required by them for monitoring participation in the sport rowing and Scottish Rowing will become a controller of your personal information when they receive it. Athletes' / Participants' personal data:

We publish the results of our competitions on our website. This includes competitors' name, age, and result.

We will share medical information with competent emergency responders (e.g. ambulance paramedics) should the need arise.

w we protect your personal information

Your personal information is stored in paper files, on trustees' personal computers and on our website. The servers are based in the UK, and access is limited to our volunteers for the purposes set out above.

Emergency contact and medical information is taken on paper or portable media to training sessions and competitions and stored securely by the volunteer responsible.

How long we keep your personal information

Members' personal data:

We will only keep your personal information for as long as necessary to provide you with membership services.

Unless you ask us not to, we will delete your personal information where you have not renewed your membership with us. We will keep a record of your name, joining and leaving date for longer in order to comply with Scottish charity legislation.

Volunteers' personal data:

We keep our volunteers' personal information while they have an association with us and for a period afterwards to be able to respond to complaints or statutory investigations.

We have a data retention policy that sets out the periods for retaining and reviewing all information that we hold. This sets out different retention periods and you can request a copy by contacting us at secretary@strathclydeparkrc.co.uk.

Your rights

You can exercise any of the following rights by writing to us at secretary@strathclydeparkrc.co.uk.

Your rights in relation to your personal information are:

- you have a right to request access to the personal information that we hold about you by making a "subject access request";
- if you believe that any of your personal information is inaccurate or incomplete, you have a right to request that we correct or complete your personal information;
- you have a right to request that we restrict the processing of your personal information for specific purposes; and
- if you wish us to delete your personal information, you may request that we do so.

Any requests received by Strathclyde Park Rowing Club will be considered under applicable data protection legislation. If you remain dissatisfied, you have a right to raise a complaint with the Information Commissioner's Office at www.ico.org.uk/.
